Active First Year Member	<p>Any individual, who qualifies as an Active Member, owns a "Class Boat" and wishes to join the club at a reduced rate for a one-year trial period.</p> <p>Class Boats are: Sunfish, Interlake, Lightning, I20 / M20, Highlander, E-Scow, and Hunter 23</p>	<ul style="list-style-type: none"> • May rent docks, lockers, racks, and trailer storage. • May perform race duty and operate Club boats. • May skipper or crew during club races. • May attend club functions and events • May utilize club facilities and entertain guests. • May vote if initiation fee is paid. 	<p>This special rate applies to those individuals who wish to bring a "Class Boat" to the club. 1st year members are included in the membership totals below.</p> <p>Active First Year members do not have voting rights and can not hold office unless the initiation fee is paid. Initiation fee is not required until 2nd year.</p>
Active Member	<p>Any individual age 21 or greater that is interested in the promotion and enjoyment of sail boating and racing, especially on Indian Lake, Ohio, shall be eligible for election as an Active Member.</p>	<ul style="list-style-type: none"> • Has voting rights • May rent docks, lockers, racks, and trailer storage. • May serve as an Officer, Trustee, or Committee Chair • May perform race duty and operate Club boats. • May skipper or crew during club races. • May attend club functions and events • May utilize club facilities and entertain guests. 	<p>Total Active 1st year, Active and Associate membership is not to exceed 100 (Past Active members do not count towards the 100).</p> <p>Of the 100 Club members, 20 may be individuals who do not own a sailboat or own a "Non-Class" sailboat kept at the club.</p> <ul style="list-style-type: none"> • Hunter 23's are recognized as a "class" within this group. • Individuals who keep a "Non-Class" boat at the club will be included in the 20 regardless of "Class Boat" ownership. <p>The term "Active" implies the member will have voting rights once all dues and fees are paid, and may keep a sailboat at the club.</p>
Active Member Under 30	<p>Any individual between the ages of 21 and 30 that is interested in the promotion and enjoyment of sail boating and racing, especially on Indian Lake, Ohio, shall be eligible for election as an Active Member.</p>	<ul style="list-style-type: none"> • Same as Active member but at a reduced membership fee. 	<ul style="list-style-type: none"> • Same as Active member
Associate Member	<p>Any individual who qualifies as an Active Member but does not desire Voting Rights or to keep a boat at the club.</p>	<ul style="list-style-type: none"> • May crew during club races. • May attend club functions and events • May utilize club facilities and entertain guests 	
Past Active	<p>Any person who has been an Active Member for ten or more years or is a Past Commodore of the Club, and no longer wishes to dock a boat at the Club.</p>	<ul style="list-style-type: none"> • May perform race duty and operate Club boats. • May skipper or crew during club races. • May attend club functions and events • May utilize club facilities and entertain guests. 	<p>Unlimited in numbers Past Active members do not have voting rights and can not hold office or keep a boat at the Club.</p>
